PRESIDENT'S MESSAGE

The Committee of The Couta Boat Club has been deeply concerned with a fundamental issue related to the Couta Boat and The Couta Boat Club in recent weeks.

We of the Committee have made a decision we earnestly believe to be correct in relation to a boat under construction at present. The immediate effect on members (and their boats) will be to see a retuning and tightening up of the rules and regulations. A member of the Club recently made the point that the real purpose of the ownership of a Couta Boat should be to enjoy it. His interpretation was that this meant getting out and sailing the boat - not just competition sailing or working on it. This simple outlook is his strong view point and when put similarly, strongly enforced the views we had when the Club was first established.

As this SCOOP is probably the last before Christmas 1985, on behalf of the Committee of The Couta Boat Club, I wish all members a most enjoyable Christmas Season and look forward to a great deal of pleasure being derived from the use of our boats in what's left of 1985 and what's to come in 1986.

DUGGA DOES IT AGAIN

Dugga Beazley gave the fleet another sailing lesson in light and variable conditions for the first PETERSVILLE SERIES RACE on Saturday, 16th November 1985.

A fleet of approximately fifteen boats started the Petersville Race 1 in a light north easterly and strong ebb-tide. Dugga sailed a perfect race leading from start to finish in an extremely light and variable wind. The rebuilt 24ft. boat "REGINA" superbly sailed by Martin Bryan was 2nd over the line.

Race Results for Port Melbourne and Petersville Series 1 are detailed in this issue.

EDITORIAL

The Committee have recently had the rather unpleasant task of ruling that a boat that does not comply with the Club Rules and Regulations is ineligible to race in Club Events. The vessel in question was at an advanced stage of construction when the ruling was sought. The whole problem could have been circumvented had, as was suggested under the Rules and Regulations, the plans been submitted to the Committee prior to commencement of construction. As a result of the foregoing the Rules, which you may recall were initially adopted at the 1983 Annual General Meeting, have been amended to make it quite clear that craft that do not comply with the Club Rules and Regulations will not be eligible to race in Club Events. The only available dispensation is in respect of vessels constructed prior to the adoption of Rules and Regulations in 1983 and even then dispensation is by no means automatic.

The Club Constitution clearly defines the Queenscliff type Couta Boat as the very reason for its existence. Accordingly if the Rules and Regulations are not adhered to the future of the Club could be in doubt. Further on in this edition of "Scoop", you will find a copy of the Rules and Regulations including amendments made up to and including the 16th of November, 1985. It is the Committee's intention to add to the Rules when the necessity arises, therefore when considering anything in connection with the yacht or its sails or equipment which is not clearly covered by the Rules and Regulations, it must be assumed illegal unless prior approval has been obtained from the Committee. Do not, if seeking approval, submit your case to the next Committee you see at the Pub. Write to the Secretary stating your case and requesting approval!

The Handicap Committee have expressed concern at rumours that some vessels have been altering the ballasting for particular weather conditions. Whilst it is totally reasonable during the course of the season to move ballast around a vessel to obtain optimum trim, it is totally unreasonable to expect a handicap for a particular boat to be valid if that boat has removed from or added to its normal ballast for a specific Club Event.


The whole idea of the handicapping system is to be as fair as possible within a set of given parameters. If a boat is re-ballasted for a specific race or the propeller removed or some such thing, it is totally unrealistic to believe that its former handicap can still apply and in this regard the Handicap Committee will be vigilant.

RULES AND REGULATIONS - AS AMENDED NOVEMBER 1985

HULL FORM

igible

8

Shall conform to the general Queenscliff type sailing, fishing boat incorporating -

- a) Moderate Draft (e.g. boat 26' o.a. draft approx. 3'3").
- b) Centre Plate (approx. 1/3 of the Keel).
- c) Beamy (e.g. boat 26' o.a. beam between 9'3"/10'3").
- d) Open, generally with round combings, raised at least 3" forward. Side decks forward generally 18" wide.

NOTE It is mandatory that boat plans be submitted to the Committee for appraisal.

HULL CONSTRUCTION

- a) Wooden, plank on edge approx. 3/4" planking.
- b) Decks wooden (laid where possible).
- c) Ribbing generally not more than 5" centres.

RIG: a) Gaff or Lug rigged.

- b) Where Lug Rig is used, mast height can be substituted for yard length.
 - MAST HEIGHT (Maximum) No more than the length of the boat, out of the deck.
 - BOOM LENGTH (Maximum) No more than 2'0" protruding over Transom.
 - 3) <u>YARD LENGTH</u> (Maximum) Except for Lug Rig. No more than 1'0" short of the Transom. This spar is allowed to be hollow.

NOTE - Spars are wooden.

4)	JIBBOOM LENGTH	(Maximum)

5) JIBBOOM OUTHAUL

To be traditional Ring Outhaul type.

JIB SIZES

The length of the foot shall not be greater than 125% of the distance between the maximum forward Tack position and the leading edge of the mast. It is recommended that three Jibs be carried, one being a Storm Jib of heavy material, cut high above the deck. Bigger Jib may be carried but, not in Club Races.

7) MAINSAILS

Should be fitted with at least 2 reefing points and reefing gear accessible and in good order.

- 8) SPINAKERS Not allowable.
- 9) RUNNING BACKSTAYS Not allowable.
- 10) WINCHES Not allowable.
- 11) SHEETING Both sheets must be of the quick release type.

12)	EXOTIC MATERIALS .	
	Not permitted - Sails:	Kevlar and Mylar Halyards, Sheets or Outhauls/Kevlar
	- Hulls:	All forms of fibreglass reinforced plastic, alloy, etc. (see Hull Construction above)

- 13) ENGINES Where fitted, should be in good working order and capable of propelling the boat i.e. properller fitted.
- 14) PUMP Boats shall be fitted with an adequate hand operated pump.
- 15) BALLAST Ballast shall not be affixed externally to the keel.
- 15) Remote adjustment of yard outhaul not allowable.
- 17) HEADSAILS Only one Headsail may be flown at a time. *

GENERAL COMMENT

The idea of the Club is to promote and race Couta Boats in the spirit of the original regattas, owners should strive to rig and maintain their vessels using traditional materials and fittings, such as wooden blocks etc.


GENERAL SAFETY

Boats shall carry safety equipment as prescribed in A.Y.F. Safety Regulations Addendum B Part 2 Category A.

DISPENSATION

Owners of boats which were constructed prior to the formulation of the Rules and Regulations may apply to the Committee of the Couta Boat Club for dispensation.

In the event of a Headsail change the sail being replaced must be lowered prior to hoisting the replacement sail.

The Rules shall be the 1985-88 Yacht Racing Rules of the I.Y.R.U. together with the Prescriptions of the A.Y.F. as modified by these Sailing Instructions. The A.Y.F. Safety Regulations for Keel Type of Ballasted Yacht Racing during Daylight Hours in Other Than Ocean Races shall apply.

2. STARTING TIME AND PROCEDURE

3. STARTING LINE

The starting line shall be a 200 metre imaginary line between the Red Buoy CBC 3 and the Committee Boat. LOCATION: WITHIN A 1.2 MILE ARC SEAWARD OF PORTSEA PIER.

4. COURSE MARKS

(Refer to attached diagrams)

Course 1 Red flag, all marks to port Start thence to Mark 1 (approx. 1.2 miles to weather) thence to 2, 3, 1, 3, 1, 2, 3, 1, 3, thence to finish.

Course 2 Green flag, all marks to starboard Start thence to 1, 2, 3, 1, 3, 1, 2, 3, 1, 3, thence to finish.

5. RECALLS

(a) INDIVIDUAL RECALLS

> No recall numbers will be displayed. Where one or more boats have started prematurely a sound signal shall be made and Code Flag "X" shall be displayed until all offending yachts have returned and started correctly, or for such shorter periods as the Race Officials The responsibility for returning shall rest with the boat(s) concerned.


Boats which fail to return and start correctly shall have a minimum penalty of 5 minutes added to their corrected time.

(b) GENERAL RECALLS

When there are a number of unidentified premature starters or an error in starting procedure the Race Officials may voice a general This shall be indicated by the display of Code Flat "1st substitute" accompanied by two (2) sound signals. The warning signal for the re-start shall be made one minute after this signal is lowered (one sound signal shall be made with the lowering of the

6. THE FINISHING LINE

The Finish Line shall be at a 200 metre imaginary line between Red Buoy CBC 1 and the Committee Boat.

7. SHORTENING THE COURSE

The course may be shortened at any mark. In the event of this the finish line shall be an imaginary line between the course mark and a Committee Vessel of the Couta Boat Club displaying Code Flag "S". A red flare <u>may</u> be launched to signify course shortening. The Committee Vessel may make frequent sound signals.

8. TIME LIMIT

The time limit shall be four (4) hours from the start. Any yacht finishing after this time shall be deemed "did not finish".

9. CANCELLATION - POSTPONEMENT -ABANDONMENT

The Race Officials may postpone, cancel or abandon the race. Indication of this shall be as follows -

Race Postponed - (will not be started at scheduled time). Code Flag "Answering Pendant" displayed with two (2) sound signals. In addition a red flare may also be launched.

Race Cancelled - (will not be sailed thereafter). Code Flag "n" over "First Substitute".

10. PROTESTS

Protests shall be lodged in writing with the Chairman of the Race Committee (Mr. Farfor) and contain -

- the date, time and whereabouts of the incident.
 the particular mile and whereabouts of the incident.
- ii) the particular rule or rules alleged to have been infringed.
- iii) a description of the incident.
 iv) unless irrelevant a diament.
- iv) unless irrelevant, a diagram of the incident.

Protests shall be lodged within one hour of the time the protesting boat finished the race.

11. ALTERATIONS TO INSTRUCTIONS

The Committee may alter these Sailing Instructions. Indication of this shall be the display of Code Flag "1" on the flagstaff on Portsea Pier no later than one hour prior to the start of the race.

If it appears that you may obstruct shipping you must start your engine and allow the shipping clear passage. You will not be penalised for


17. INDEMNITY

Handicaps for Couta Boats shall be as previously published or as amended by the Couta Boat Club Handicap Sub-Committee.






